**TRAINING CONTRACT / BOARDING**

This is a contract between *Bearpoint Kennel LLC, Black Forest Kennel, Dale and Brenda Merritt* and the dog owner, \_\_\_\_\_ (Print Clearly).

Bearpoint Kennel LLC agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed. The dog(s) is to be fed properly and regularly, and to be housed in clean safe quarters.

If the dog(s) becomes ill or if the state of the animal's health otherwise requires professional attention, Bearpoint Kennel LLC, Dale, and Brenda Merritt in its sole discretion, may engage the services of a veterinarian of its choosing, administer medicine, or give other requisite attention to the animal, and the expenses thereof shall be paid by Owner.

All dogs are boarded, handled, and cared for by Bearpoint Kennel LLC, Black Forest Kennel, Dale, and Brenda Merritt, without liability on, Bearpoint Kennel LLC, Dale and Brenda Merritt and its employees for loss or damage from disease, theft, fire, death, running away, injury, or harm to persons, other dogs, property by said dog, or other unavoidable causes, when due diligence and care having been exercised. If an unforeseen and unfortunate death were to occur to a dog, Bearpoint Kennel LLC, Dale, and Brenda Merritt will deliver the dog to veterinarian of its choosing to be held for the owner to make the decision of how the dog's remains will be handled. Owner waives and releases, Bearpoint Kennel LLC, Black Forest Kennel LLC, Dale, and Brenda Merritt from all liability of any nature that the dog may suffer after being boarded.

**Int \_\_\_\_\_: (Training Only)** The owner agrees to pay Bearpoint Kennel LLC, Dale, and Brenda Merritt **Boarding \$375.00 and \$175.00 Training, Totals \$550.00/month plus birds** per dog for the various training programs: During puppy training: Bird introduction, Gunfire introduction, obedience, upland skills (pointing), retrieving, at between 5 and 6 months the puppy will be moved over to full training program, at which time we will update the training contract. **First months Training fee is due on delivery of dog.** Bearpoint Kennel LLC, Dale and Brenda Merritt will evaluate the dog(s) for a period of two (2) weeks. After this evaluation period, if it is deemed the dog(s) is unable to train correctly, then the Owner is entitled to fifty percent (50%) of the **\$550.00 monthly** fee returned, less any birds used. Owner further agrees that the dog(s) shall not leave Bearpoint Kennel until all charges are paid to Bearpoint Kennel LLC or Dale and Brenda Merritt by Owner. Owner of dog(s) left at Bearpoint Kennel beyond the agreed pick-up date will be charged for boarding rate of twenty dollars (\$45.00) per day until dog(s) is claimed. Bearpoint Kennel LLC, Dale and Brenda Merritt shall have, and is hereby granted, a lien on the dog(s) for all unpaid charges resulting from boarding and/or training dog(s) at Bearpoint Kennel.

**Int \_\_\_\_\_: (Boarding Only)** All Dogs that are here for Boarding, the owner agrees to pay Bearpoint Kennel LLC, \$35.00 per Day. Day includes the day dropped off plus day picked up, that include feeding times. Date Drop off: \_\_\_\_\_ Date to Pickup: \_\_\_\_\_. Dogs not picked up within 48 hours of scheduled pickup date may be subject to \$45.00 per day rate.

**Int \_\_\_\_\_: (Training or Boarding)** Owner of all dogs boarded or in the care of, at facility of Bearpoint Kennel LLC, Black Forest Kennel, Dale, and Brenda Merritt, give permission to Bearpoint Kennel LLC, Black Forest Kennel, Dale and Brenda Merritt to Co-mingle and/or socialize with other dogs at this facility

It is understood by Bearpoint Kennel LLC, Dale and Brenda Merritt, and Owner that all provisions of this Contract shall be binding upon both parties thereunto for this visit and for all subsequent visits.

And each of them; their officers and employees, hereinafter referred to as "**releases**" from all Liability of the **Releaser.**, his or her spouse, legal representatives, heirs, and assigns, for all loss of damage, and any claim of damage, resulting there from, on account of injury to **Releaser's** person or property. Even an injury resulting in death of **Releaser**, unless caused by willful and wanton gross negligence of **Release's**, while the **Releaser** is being guided on sport hunting or sport shooting activities of any kind on the above describe real property.

Merritt, it's agents, officers, directors, and employees as a result of physical injury incurred as a result of guided hunting or sport shooting activities except to the extent such claim might base on the sole and exclusive negligence of, Bearpoint Kennel, Dale R.& Brenda K. Merritt, it's agents, officers, directors, and employees for physical injury to others, or for property damage, which results from **Releaser's** participation or observation in guided hunting, hunting, or sport shooting activities under the terms of this agreement.

**Releaser** expressly agrees that this Release, Waiver, and Indemnification Agreement is intended to be broad and inclusive as permitted by law of the State of Colorado. And that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding, continue in full for force and effect. It is further agreed that this Release, Waiver, and Indemnification Agreement shall remain in full force until canceled and terminated in writing by either party.

**Releaser** agrees that any pictures and / or videos taken during any Training or Seminar that Dale and Brenda Merritt or Bearpoint Kennel LLC., put on, are the property of Dale and Brenda Merritt and Bearpoint Kennel LLC. Any miss use of Pictures or Videos will be considered infringement of rights, without written permission.
